I am deeply saddened by the martyrdom of innocent Pakistani citizens in drone attacks and strongly condemn it. I direct the Khyber Pakhtunkhwa government to register a protest with the federal government and stop these drone attacks immediately. The killing of innocent civilians in drone attacks does not reduce terrorism but rather increases it. After our struggle for many years, American drone attacks in Pakistan were stopped. If you are against terrorism, do not drop bombs on the homes of your own people.

Masha Allah, General Asim Munir became a Field Marshal. It would have been better if he had given himself the title of King instead of Field Marshal, because the law of the jungle is currently prevalent in the country and in the law of the jungle there is a " KING ".

The rumors that are being spread about a deal with me, no deal has been made nor are there any talks regarding a deal, are all lies.

After the way our forces, especially the Air Force, have thwarted Modi's ambitions, I fear that he will now commit more foolish acts, for which we as a nation must be prepared.

I myself am inviting the establishment that if they want to talk in the interest of Pakistan, if they are concerned about Pakistan, then come and talk. At this time, the country will have to come together to deal with external threats, growing terrorism, and the restoration of the economy. I was not asking for anything for myself before, nor will I ask for anything now.

In Pakistan, an environment has been created where the law is only for the weak, not for the powerful. This is the biggest flaw in the system. Democracy is based on two fundamental things:

Morality

Today, both these pillars of democracy have been razed to the ground. The current situation is a sign that the spirit of democracy is being crushed.

When you give the message to the people that the bigger the thief, the bigger the position he will get, then justice is lost. NAB has a case against Asif Zardari's sister for five apartments, which are in the names of employees. He himself is out of the country, and no one is going to ask. There was a case of money laundering of Rs 22 billion against Shahbaz Sharif, despite this he was made Prime Minister.

In the last three years, the moral values ??and constitutional structure of Pakistan have been completely destroyed. The ridiculous trial in the Toshakhana II case has been restarted. Like the rest of the prison, the prison court is also run by the will of a colonel. Even my sisters and lawyers are being prevented from coming to the court. Even my colleagues are not allowed to meet me. My children have not been allowed to talk to me for months. My books are not even allowed to reach me, nor is access to my personal physician allowed. All this is a continuous contempt of court orders and laws.
